**1. GENERAL CONDITIONS**

1.1 The following preference point systems are applicable to all bids:

- the 80/20 system for requirements with a Rand value of up to R 50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R 50 000 000 (all applicable taxes included).

1.2 The value of this bid is estimated not to exceed R200 000 (all applicable taxes included) and therefore the **80/20 points** system shall be applicable.

1.3 Preference points for this bid shall be awarded for:

- (a) Price; and
- (b) B- BBEE Status Level of Contribution.

1.3.1 The maximum points for this bid are allocated as follows:

1.4 Failure on the part of a bidder to fill in and/or to sign this form and submit a B-BBEE Verification Certificate from a Verification Agency accredited by the South African Accreditation System (SANAS) or a Registered Auditor approved by the Independent Regulatory Board of Auditors (IRBA) or an Accounting Officer as contemplated in the Close Corporation Act (CCA) together with the bid, will be interpreted to mean that preference points for B- BBEE status level of contribution are not claimed.

1.5. The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.

**2. DEFINITIONS**

2.1 **“all applicable taxes”** includes value-added tax, pay as you earn, income tax, unemployment insurance fund contributions and skills development levies;

2.2 **“B-BBEE”** means broad-based black economic empowerment as defined in section 1 of the Broad-Based Black Economic Empowerment Act;

- 2.3 **“B-BBEE status level of contributor”** means the B-BBEE status received by a measured entity based on its overall performance using the relevant scorecard contained in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act;
- 2.4 **“bid”** means a written offer in a prescribed or stipulated form in response to an invitation by an organ of state for the provision of services, works or goods, through price quotations, advertised competitive bidding processes or proposals;
- 2.5 **“Broad-Based Black Economic Empowerment Act”** means the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- 2.6 **“comparative price”** means the price after the factors of a non-firm price and all unconditional discounts that can be utilized have been taken into consideration;
- 2.7 **“consortium or joint venture”** means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract;
- 2.8 **“contract”** means the agreement that results from the acceptance of a bid by an organ of state;
- 2.9 **“EME”** means any enterprise with an annual total revenue of R5 million or less .
- 2.10 **“Firm price”** means the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax, which, in terms of the law or regulation, is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;
- 2.11 **“functionality”** means the measurement according to predetermined norms, as set out in the bid documents, of a service or commodity that is designed to be practical and useful, working or operating, taking into account, among other factors, the quality, reliability, viability and durability of a service and the technical capacity and ability of a bidder;
- 2.12 **“non-firm prices”** means all prices other than “firm” prices;
- 2.13 **“person”** includes a juristic person;
- 2.14 **“rand value”** means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties;
- 2.15 **“sub-contract”** means the primary contractor’s assigning, leasing, making out work to, or employing, another person to support such primary contractor in the execution of part of a project in terms of the contract;
- 2.16 **“total revenue”** bears the same meaning assigned to this expression in the Codes of Good Practice on Black Economic Empowerment, issued in terms of section 9(1) of the Broad-Based Black Economic Empowerment Act and promulgated in the *Government Gazette* on 9 February 2007;
- 2.17 **“trust”** means the arrangement through which the property of one person is made over or bequeathed to a trustee to administer such property for the benefit of another person; and
- 2.18 **“trustee”** means any person, including the founder of a trust, to whom property is bequeathed in order for such property to be administered for the benefit of another person.



- 5.2 Bidders who qualify as EMEs in terms of the B- BBEE Act must submit a certificate issued by an Accounting Officer as contemplated in the CCA or a Verification Agency accredited by SANAS or a Registered Auditor. Registered auditors do not need to meet the prerequisite for IRBA’s approval for the purpose of conducting verification and issuing EME’s with B-BBEE Status Level Certificates.
- 5.3 Bidders other than EMEs must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a Registered Auditor approved by IRBA or a Verification Agency accredited by SANAS.
- 5.4 A trust, consortium or joint venture, will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 5.5 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 5.6 Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 5.7 A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- 5.8 A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.

### 1 TREE PURCHASE SPECIFICATIONS

- 1.1 All plant material, with the exception of replanted trees and shrubs, shall be from registered **SANA nurseries** and be healthy, have vigorous growth potential and be free of scars, parasites and insects.
- 1.2 **No pot-bound** plants shall be accepted. Plant containers shall be weed-free. Soil in plant containers shall be supplemented regularly as necessary to prevent exposure of roots. Only approved soil or compost shall be used for this purpose.
- 1.3 Plants in containers shall be well rooted and have a balanced root ball. Roots shall be spread evenly throughout the growth medium. **Plants shall be in containers for a minimum of six months.**
- 1.4 Where plants are kept on site for long periods of time and the roots grow out of their containers the plants have to be replanted in bigger containers.
- 1.5 **No plants that are bruised, broken or misshaped shall be acceptable.** Dead plants shall be removed immediately. The tree must have a well-developed with a symmetrical canopy and a clear undamaged stem; no multi-stem or no die-back or pruning of the apex is permitted. No pollard trees will be accepted.
- 1.6 Plant sizes can be larger than the required size according to the planting list.

- 1.7 Container sizes shall meet the specifications set out in the specifications below. If the specified size of the planting material is unavailable the Supplier may provide alternative tree species during the pricing process.
- 1.8 The Municipality reserve the right to reject any tree that's not compliant to the specifications. Inspection of trees and acceptance of delivery is subject to conforming to all the standards as set out in this specification
- 1.9 Plants shall be transported with care to prevent damage to the plants. Branches shall be tied in such a manner so as not to break or damage them. Points of contact with equipment shall be padded.
- 1.10 If the plants are transported to site in an open truck, the Supplier shall:
  - protect the root balls, trunks, branches and leaves from sun and wind desiccation by placing shade netting over them;
  - lie tall plants down on the floor of the truck; and
  - thoroughly water all plants on arrival on site.
- 1.11 Stellenbosch Municipality reserves the right to pay the successful supplier within **30 days of the invoice date.**

## 2 TREE PLANTING SPECIFICATIONS

- 2.1 The best time to plant trees is in autumn or early winter when trees are dormant and the weather conditions are cool, it also allows time for their roots to settle and establish before the warm summer months.
- 2.2 Make sure that you have located all **underground services** e.g. pipes and cables, before digging the tree pit.
- 2.3 The size of the tree pit depends on the size of the tree that will be planted. Dig a square pit. The pit should be 3 times wider than the base of the tree ball/container. **The pit may not be less than 750mm deep and 750mm wide** because the majority of tree roots develop in the in the top 300mm of soil.
- 2.4 Mix 50% of the excavated soil from the pit with the same amount of compost. The compost must be from well-decayed organic material free from any harmful salts and other impurities with a pH not higher than 7.
- 2.5 Apply a **slow release fertiliser** to the bottom of the tree pit and work it into the soil.
- 2.6 Make sure that the tree is **free from scars, pest, weeds or insects.**
- 2.7 Place the tree in the tree pit without disturbing the roots or the soil after carefully removing the bag/container.
- 2.8 **Backfill pit with the soil and compost mix**, while keep the tree trunk upright. Make sure that the tree is planted at the same depth as in the container. Stake the tree if the tree trunk is less than 50mm Ø with a suitable treated timber stakes. Fix the stake and tree trunk with wire and hosepipe.
- 2.9 **Make a well around the tree trunk** and water thoroughly until all air pockets have disappeared.
- 2.10 Apply a **50mm layer of organic mulch** e.g rough compost or bark chips, in the well to reduce evaporation.



### 3 AFTER CARE/MAINTENANCE

- 3.1 Water the tree **twice a week with 5 litre of water.**
- 3.2 Apply an **appropriate fertiliser twice a year**
- 3.3 Regularly inspect for pests and diseases
- 3.4 **Remove weeds around tree.** If the tree is planted in a lawn area, make sure that you do not accidentally ring bark the tree when mowing the lawn with a weed eater. To protect the tree you can use a perforated PVC pipe to cover the lower part of the tree trunk.
- 3.5 Apply mulch in the dam well around the tree every spring
